

### M'KIS WEBSITE PRIVACY POLICY

Mont'Kiara International School ("M'KIS"), is committed to comply with the Malaysian Personal Data Protection Act (PDPA) 2010 in protecting personal information that has been processed by M'KIS. This Privacy Policy informs you about M'KIS's policy and practices on data privacy matters before you provide your personal data to us when you visit www.mkis.edu.my (the "Website") or through other methods as stated in the section "Collection of Personal Information" below.

By using the Website you consent to the collection/retention and use of your personal information in accordance with this policy.

#### **Collection of Personal Information**

We collect your personal data upon and throughout the course of your relationship with us including:-

- iv. Class work (written, visual or in any other form) created, conceived and produced for academic or non-academic purposes ("Class Work") by you;
- v. Your health records;
- vi. The particulars of your travel document(s);



- vii. The contents of all information obtained from the website, forms and/or documents collected by us; and/or
- viii. Other information

### c. Alumni

- i. Your personal details, including the details relating to other person(s) who may be identified from the data;
- ii. Employment information;
- iii. The contents of all information obtained from the alumni's website, forms and/or documents collected by us; and/or
- iv. Other information

(collectively referred to as "Personal Data").

### **Use of your information**

### Storage of your information

Your information will be processed and stored as long as it is necessary for the purposes described in this Privacy Policy as well as for the purposes of ensuring the security and integrity of M'KIS information systems. We will retain and use Your Personal Data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes and enforce our legal agreements and policies.



M'KIS will also store usage information for internal analysis purposes. Usage information is generally retained for a shorter period, except when this data is used to strengthen the security of to improve the functionality of our service, or we are legally obligated to retain this data for longer time periods.

### **Disclosure of your information**

Authorized personnel within M'KIS will be able to access the information you provide to us. We may also disclose your information to other third parties who act for us for the purposes set out in the policy or for purposes approved by you.

Please note that countries outside Malaysia may not always have the same strong data protection laws. However, we will always take steps to ensure that your information is used by third parties in accordance with the terms of this Privacy Policy.

Unless required or permitted to do so by law, we will not otherwise share, sell or distribute any of the information that you have provided to us without your consent.

### IP addresses and cookies

We may collect information about your computer, including where available your IP address, operating system and browser type. This information is statistical data about users' browsing actions and patterns, but does not identify any individual. It is used to inform improvements for the website, for system administration, and to report aggregate information to third parties.

For the same reasons, we use cookies on this Website. Cookies are small amounts of information that we transfer to your computer's hard drive through your web browser. They tell us when you have visited our site and where you have been. They do not identify you personally, just the presence of your browser. Cookies make it easier for you to log on and use the site during future visits. They also enable us to provide you with a more personalized service. Should you wish to do so, your browser's help section should be able to warn you before accepting cookies and how to filter or disable them, although in the latter case, you may not be able to use certain features on our site.
